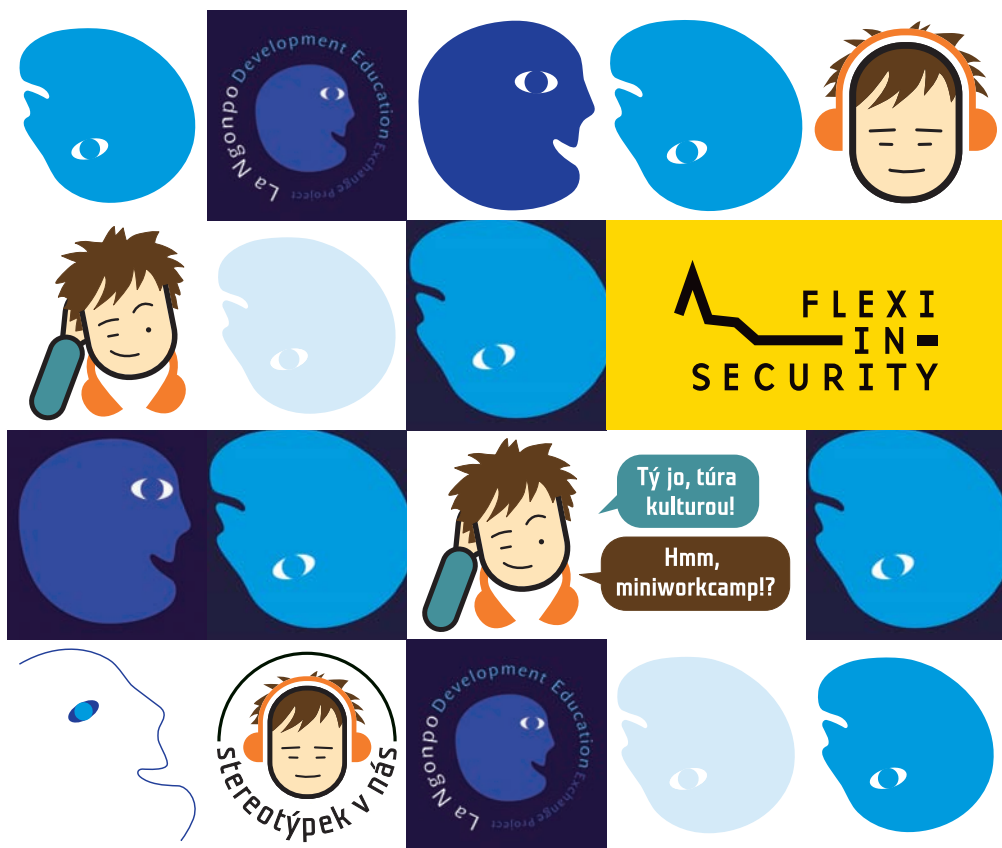

INTRODUCTION

I only started working at the Multicultural Center Prague in late April, so taking stock of last year's work is not easy for me. I found it difficult, in particular, to get acquainted with all the activities through which the organisation aims to fulfil its mission and goals. Nevertheless, I hope that after eight months of hard work, and thanks to very good cooperation among all of our staff, I was able to grasp what this organisation is about, and I am now in a position to evaluate past events and tell you about those lying ahead.

I can only sum up MKC Prague's activities of the first three months from an observer's point of view. At the beginning of the year one of our core educational projects was launched: La Ngonpo, a project focusing on parallel education of children in Czech and Indian schools, based on a web portal. At the same time a number of projects linked to the long-term activity of the www.migrationonline.cz web portal were underway, focusing on integration of foreign nationals, labour migration, visa policies, irregular migration, etc. The organisation also continued its seminars, courses and debates on multicultural education for children and adults from various working environments. MKC Prague traditionally prides itself on its resource centre which regularly monitors and acquires publications on multicultural topics and serves as a resource for both the general public and researchers.

During the second quarter I already had the opportunity to look at MKC Prague from the inside: I went through a selection procedure and became the Executive Director of MKC Prague. The spring months were devoted to our new projects. The project Flexi-in-Security, launched in April, combines the work of photographers and journalists who present, in a creative way, the life stories of migrants living not only in the Czech Republic, but also in other European countries. The aim of this project is to show the general public what impact

the global crisis has had on labour migration. In early June our second – and equally important – project was started, entitled The Stereotype in Us. This project focuses on preventing xenophobia and racism among vocational secondary school students from selected regions of the Czech Republic.

Our work in the third quarter was marked by the devastating floods in Ladakh, India, where our coordinator of the La Ngonpo project and a number of volunteers were working at the time. The floods paralysed the implementation of the project for some time and – what is worse – had a terrible impact on the lives of the local inhabitants. The purpose of our people's stay therefore changed dramatically when, quite spontaneously, they made every effort to help mitigate the impacts of this natural disaster.

A number of less dramatic events also took place during the summer, representing the outcome of the organisation's activities. In particular, the projects European City and Libraries for All were terminated successfully. Within the first project a number of seminars were organised for young Europeans interested in integration in the urban space, leading to the creation of an internet portal (www.evropskomesto.cz) administered by MKC Prague. The highlight of the second project was an exhibition of artwork by foreign nationals which started with a festive opening in the Opatov branch of Prague's Municipal Library. During the opening ceremony the results of an art competition for immigrant children were announced and a fashion show took place where mainly foreign designers had the opportunity to present their work. As the new project The Stereotype in Us was launched in the summer, the coordinator of the MigrationOnline web portal became the methodologist for intercultural seminars and workshops, and a new portal editor was chosen among over a hundred candidates in a demanding selection procedure. At



that time we obtained further support for the portal from the Open Society Fund Prague Foundation, and the last year of the foundation's support thus started. The MKC Prague's management as well as the whole migration team are therefore facing a big challenge: finding resources for further operation of the portal which has become an integral part of MKC Prague.

The end of the year was marked by events that were also important for the functioning of the organisation in the year to come. In Ladakh, India, the pilot for the first topic of the La Ngonpo project was implemented, although on a reduced scale. We are planning to bring the project into more schools in the Czech Republic and are making first steps towards cooperation with schools in other countries. The development of methodology for the project *The Stereotype in Us*, reflecting modern trends in multicultural education, has been finished successfully and the methodology is ready for the pilot phase which will take place in the next semester. Both projects seem to have a great potential for the organisation's future educational activities as well as for personal development of its staff. Another successful event, part of the project *Multicultural Europe in the Media*, was the seminar for journalists where journalists from major Czech media met people from the NGO sector to discuss how to present the image of migrants, minorities and multicultural coexistence in an efficient and balanced manner. This seminar also represents an important potential for the future activities of our organisation.

In cooperation with the Consortium of Migrants Assisting Organisations in the Czech Republic and the Migrant Rights Initiative we focused on efforts to initiate constructive dialogue across society about modifying the amendment to the Aliens Act, finding a new strategy for the integration of foreigners, and making suggestions for the Government's economic migration policy. There is no doubt that our organisation will continue its efforts leading to effective social inclusion of migrants. Indeed, the project *Regularisation as One of the Tools for the Fight against Irregular Migration* is at its most intense phase, making

maximum effort to improve the living conditions of migrants and advocate for their rights, especially those who have lost their residence permits due to the economic crisis. With a growing number of voices coming from the western world in the past few months, saying that multiculturalism has failed, a society-wide debate on how nations should live together is becoming increasingly important.

Our work in 2011 will follow the plan that we drafted together at the autumn strategic planning session. In addition to our regular work meetings we are planning to have meetings based on expert debates that will aim to further our employees' personal development and help define and develop our activities in the two key thematic areas of our work: multicultural education and migration. In the frame of our educational activities we are preparing accreditations for new teacher courses as well as more intercultural education courses for employees in the corporate sector, we are planning new projects and starting cooperation with both Czech and foreign partners. Our migration-related activities will culminate in a number of debates, conferences and exhibitions which will present the outcome of some of our finishing projects to the general public. We are also seeking support for a number of new projects which would help us continue our work on interesting topics, develop the network of our domestic and foreign partners, and support the functioning of the MigrationOnline web portal.

The greatest challenge we are facing is to interlink the organisation's educational activities with migration-related topics. Our multicultural seminars for teachers and students, journalists, civil servants and company employees represent one of the options. These seminars focus on foreigners coming from those countries that our domestic migration-related activities are intended to benefit. This could help us fulfil our most meaningful mission: take over a part of the responsibility for progress in 'third countries', which is something that economically and socially developed countries should not renounce – in their own interest but, above all, in the interest of the whole world.

MOTTO

The 20th century led to the erosion of the Czech land's multicultural heritage. With the Czech Republic's integration into the European Union and other global political and economic structures, Czech society is again becoming diverse and multicultural. A multicultural society enriches and stimulates, but it can also create tensions and misunderstandings. The Multicultural Center Prague aims to help all people understand and explore this multi-layered reality.

The Multicultural Center Prague is an unincorporated association founded in 1999, focusing on issues of coexistence between people from different cultures in the Czech Republic, but also in other parts of the world.

Since its beginnings the Multicultural Center Prague has been pursuing its goals through public debates, educational, cultural and information activities, publications and networking among people and organisations that focus on the same issues, both from the Czech Republic and from other countries.

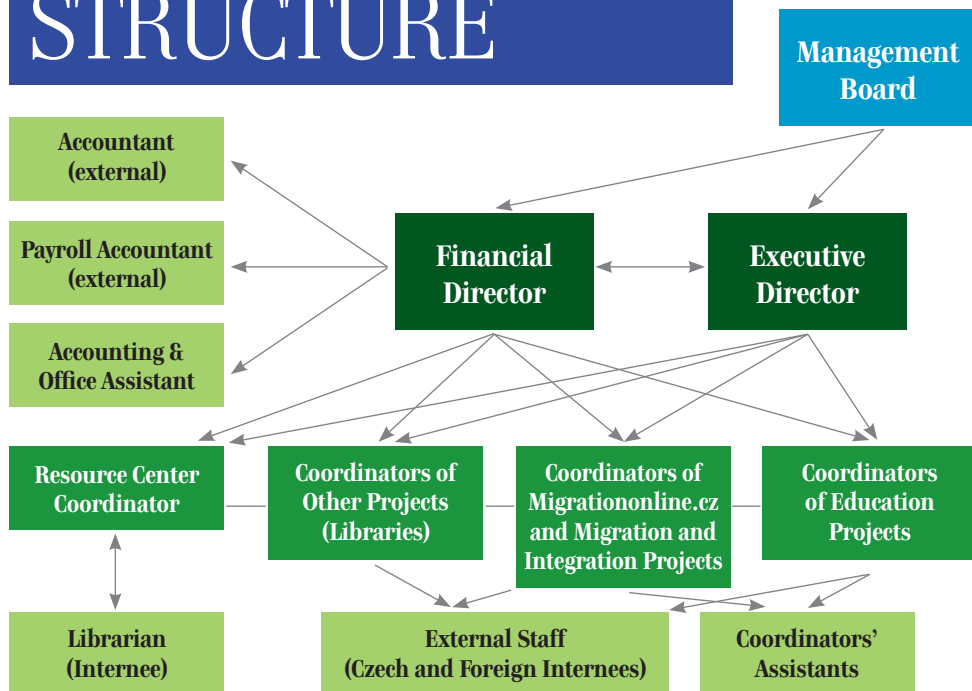

RESOURCE CENTRE AND LIBRARY

The resource centre and library of the Multicultural Centre Prague offer scholars and the general public a wide range of information resources about cultural, linguistic, ethnic and religious diversity and the coexistence of different cultures in the Czech Republic and in the world.

The library of MKC Prague currently houses over 2750 books, 160 audio-visual items and 50 different periodicals grouped in specialised thematic sections from religion and mythology, nations and national identity, minorities' rights, migration and refugees, to anthropology, ethnology and ethnography, intercultural education and learning, diversity management and multicultural fiction. Most publications are in Czech or English. The library also provides research services, as well as access to the Czech Newton Media newspaper article database.

The library offers internships on a regular basis for students of librarianship and information studies, providing them with detailed information about how the library works (acquisitions, cataloguing, review, loan protocol, communication with readers, etc.).

In January 2010 we launched the international project La Ngonpo which focuses on global development and multicultural education. This three-year project targeting students aged 13 to 15 runs at basic and secondary schools in the Czech Republic and Ladakh, India. The main objective of the project is to familiarise Czech students with development issues and help them better understand themselves and their culture, as well as raise public awareness of development issues.

Funding from the European Commission and the Czech Ministry of Foreign Affairs made it possible to create a new methodology and run the www.la-ngonpo.org portal as a meeting place for students and teachers from participating schools. Pupils and students take part in the 24 La Ngonpo lessons run by their teacher according to the original methodology, they participate in a film workshop and a photography course. A documentary will be made about the lives of pupils and students from both countries. Photographs and other project outputs will be exhibited in public areas of several larger towns of the Czech Republic and also in Ladakh, India. In addition, Czech IT experts will help adjust the PC network and internet connection for the project in the Indian schools and people with teaching experience will help local teachers to use the La Ngonpo methodology in their classes.

Currently the pilot phase of the project is underway; since November 2010 the methodology has been tested at four Czech basic and secondary schools (in Brno, Beroun and Prague) and two Indian schools. From September 2011 we plan to increase the number of participating schools to 10 in each country. From 2012 other schools will be able to use the methodology and the website as well, which will give them the opportunity to connect with schools from around the world.

THE STEREOTYPE IN US - Through Intercultural Education and Experience Towards Tolerance

In June 2010 we launched another education project, The Stereotype in Us. MKC Prague is the main coordinator and the project partners are INEX – Association for Voluntary Activities and AFS-Intercultural Programmes. The project is carried out in five selected regions of the Czech Republic (the Central Bohemian, Southern Bohemian, Plzeň, Karlovy Vary, and Hradec Králové Regions).

The main objective is to prevent xenophobia and racism among vocational secondary school students by means of intercultural education. We use interactive and experiential methods, and foreigners and members of minorities participate directly in the classes, which is a great benefit.

In 2010 we prepared the methodology for the educational programme for students. In 2011 we will work on seminars for teachers and other staff dealing with youth education and free time activities. We will show the participants practical methods they can use in intercultural classes and familiarise them with the project methodology for education in schools. In February 2011 we will launch the website <http://stereotypék.mkc.cz/>, an information portal where all of the project outputs will be available together with a database of lecturers. The information portal will serve as a platform for sharing ideas and mapping the activities related to intercultural education.

The year 2010 was already the eighth year of our specialised website MigraceOnline.cz (MigrationOnline.cz), one of the most important information resources on international migration in the Czech Republic, unique in its scope. In 2010, like in the previous years, the activities related to the website were made possible by funding from the Open Society Fund Prague.

In its beginnings the portal was unique in that it published both scientific and practical texts by different authors with academic, public administration and NGO backgrounds. The website MigraceOnline.cz thus became a forum for debates on migration trends in the Czech Republic and its neighbouring countries which played (and still play) an important part in reflections on the Czech Republic's migration and asylum policy. We keep innovating the website, seeking to fulfil its informative function with a special emphasis on current events related to the situation of foreigners in the Czech Republic. This is why we keep bringing up new topics. In 2011 we plan to launch a new topic focusing on the exploitation of labour migrants working in the Czech forestry sector. We maintain the information on migration up to date by everyday press monitoring. We inform our readers about legislative developments and about upcoming educational and cultural events related to migration.

MigraceOnline.cz is changing not only in terms of content, but also in terms of its visual image. Thanks to the use of modern communication technologies it is becoming more interactive and more attractive for the readers. The blog section of MigraceOnline.cz, where people can read migrants' stories, is very popular. Recent additions include the Visawatch blogs (launched in November 2010) which recount the experience of visa applicants with Czech consulates and embassies. The portal found new supporters through the MigraceOnline.cz Facebook group which was created in July 2010 and had 235 members by the end of 2010. The MIGRACE e-mail newsletter is another popular communication channel. The subscribers are sent regular overviews of new articles published on the MigraceOnline.cz website and are informed about interesting events organised by MKC Prague and other organisations. In 2011 we plan to introduce podcasts as well as audio and video recordings of the events we organise, in order to get our activities closer to those who cannot participate directly.

The growing interest in our website is evidenced by the increasing number of visits. The highest number of visits for 2010 was recorded in April (1628 visits per day). This is a remarkable success in comparison with previous years when we counted the visits in hundreds (600 visits a day in 2007, 400 in 2005, 240 in 2004). We are also happy about the foreign readers' growing interest in the English version of the website – MigrationOnline.cz. In October 2010, for example, the website was visited by readers from 116 countries; most of them were from countries like USA, France, United Kingdom, Germany and Ukraine but, quite surprisingly, even people from Bahrain, Fiji and Trinidad and Tobago found their way to our website.

In 2010, 81 articles were published on the MigraceOnline.cz portal, along with 65 other contributions such as invitations to cultural and educational events, outcomes of activities carried out by our partner NGO organisations working with migrants, press releases from the Czech Republic and abroad, the newsletter of the Consortium of Migrants Assisting Organisations in the Czech Republic, etc.

FLEXI-IN-SECURITY is a joint project of five NGOs and cultural organisations from the Czech Republic, Poland, Germany, Sweden and Belgium, created in reaction to the economic crisis and its impacts on the situation of migrants; its objective is to promote respect for migrants' human and social rights. The EU member states have committed themselves to the principle of 'flexicurity', a balance between labour market flexibility and social security. The project FLEXI-IN-SECURITY aims to raise awareness of the situation of labour migrants and the current situation of human and social rights in selected EU member states.

In 2010 several meetings brought together ten research teams from different European as well as non-European countries, who spent six months studying the situation of migrants in Europe and worked their findings into photo stories and articles. In 2011 the outputs will be presented in the form of a series of exhibitions in the Czech Republic, Germany, Poland, Belgium, Sweden and France. Experts as well as the general public will have the opportunity to take part in a series of debates on migration issues in the Czech Republic (the new economic strategy, the Czech visa policy) and the closing international conference. Experts will be offered migration case studies from Germany, Poland, Belgium and England, as well as a document that sums up recommendations for further development of the Czech Republic's migration policy.

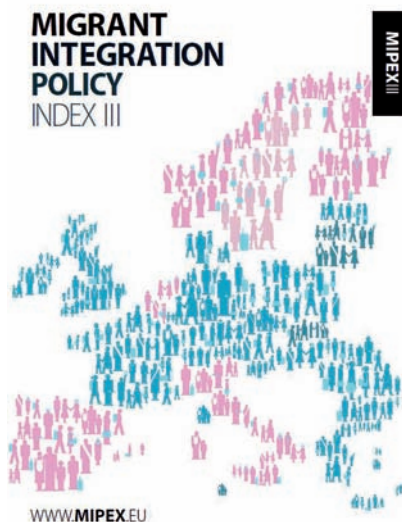

MIPEX is a unique Europe-wide project which compares immigration policies of different European countries, the US and Canada. It aims to create a comprehensive picture of migrants' possibilities for social integration in a given country. An interactive website making it possible to compare different government policies in areas such as labour market access, access to education or citizenship, will be the main output of the project. From MKC Prague's point of view, though, the key role is to publicise the outcomes of the project in the Czech Republic by organizing a conference in May 2011. We want to use the conclusions of the MIPEX project as a starting point for further debate on Czech and European migration policy. In addition to the original project partners – the British Council and People in Need – Respekt Institut will participate in these activities.



VISAWATCH – WHAT IS THE SITUATION AT CZECH CONSULATES AND EMBASSIES?

The VISAWATCH project reacts to a neglected, yet important part of migration policy: visa issues. In 2007 and 2008, the years of the economic boom, Czech embassies in the main source countries for immigration to the Czech Republic – Vietnam, Ukraine and Mongolia – were facing unprecedented numbers of visa applicants. Deficiencies in the system and insufficient capacities resulted in long lines where people waited for several days and where place selling, soaring prices and corruption became common practice. The current situation cannot be more different. With the onset of the economic crisis the Czech Republic stopped issuing visas at first, and then reduced their number dramatically through the Visapoint registration system. There are no more lines in front of Czech embassies. But what lies behind this peace and quiet?

The project aims to raise general awareness of visa issues and point to the most serious problems associated with visas. The main project outputs include texts on visa issues published in the 'Migration and Visas' and 'Visawatch blogs' sections of www.migraceonline.cz, a final public debate, and a series of video spots for Respekt multimedia. The online publications sum up the developments of recent years as well as current recommendations; they will be published in spring 2011.

PROSINT is one of our research projects. It studies existing integration policies and measures in the Czech Republic from the point of view of public administration, academia and NGOs, using the method of in-depth interviews.

In 2010 we carried out the following research activities:

More balanced news, unbiased reporting, greater involvement of foreigners themselves in the media coverage of migration issues: these are the main objectives of the European project Europe in the Media. Being the second project of this type carried out by the Dutch organisation Mira Media, this project focuses mainly on the situation in the countries of Central and Eastern Europe. MKC Prague as one of the project partners maps the situation in the Czech Republic.

The workshops for journalists and NGOs which took place in autumn were a great success and attracted a number of participants from both groups – despite the sceptics who said that journalists are usually not interested in such events. Similar groups of participants will take part in the 2011 round table which will follow up on these seminars. A DVD was published as part of the project, as well as a manual that will serve as training material for workshops and seminars focusing on the media and foreigners.

Through our membership in the Consortium of Migrants Assisting Organisations in the Czech Republic we help to implement the project funded by the Open Society Fund Prague as part of the special grant programme 'Improving the Situation of Labour Migrants'. The project aims to improve the coordination and communication between member organisations of the Consortium and involve migrant organisations in the activities of the Consortium and other migration-related activities of the NGO sector. To fulfil this objective the project promotes advocacy and lobbying, trying to strengthen the voice of migrants and their organisations represented in the Consortium on a political level and in addressing the public. At the same time the project aims to support fieldwork focusing on labour migrants and their families in the Czech Republic.

The project Libraries for All focused on education and integration of foreign nationals in a library environment, opening and adapting the libraries and their services to the needs of migrants or, more precisely, to the three main target groups: foreigners living in Prague, library staff, and members of the majority society. Within the project MKC Prague supported the Prague Municipal Library in

providing more services for migrants, establishing new contacts with organisation that work with migrants both in the Czech Republic and abroad, and providing further education and training for the library staff.

The main project outcomes include:

- Publishing information materials about the library in seven languages (English, German, Chinese, Vietnamese, Russian, Ukrainian, Mongolian)
- Creating two Infopoints for foreigners (The Central Library and the Opatov branch) which provide access to information materials, PCs with e-learning language courses, Internet access and basic software
- PC courses for foreigners at the Opatov branch
- Czech language courses for foreigners organised at the Central Library and the Prague 1 branch (cooperation between MKC Prague and the Centre for Integration of Foreigners)
- Publishing a manual for librarians which helps them communicate with readers who do not speak sufficient Czech

BUYING BOOKS FOR NATIONAL MINORITIES

With this project we focused on regular readers, members of national minorities and foreigners, making available to them mostly foreign literature on popular multicultural issues that is hard to find in other public libraries. In 2010 we bought scientific publications on the following topics: multicultural education; Czech language textbooks for learners and teachers of Czech as a foreign language; diversity management; law.

The evaluation committee for the 2011 ERSTE Foundation Award for Social Integration included two of MKC Prague's projects – 'Czech Made? Against Double Standards and Exploitation of Migrants in the Czech Labour Market' and 'Libraries for All / European Strategy for Multicultural Education – among the 15% of projects that received the best evaluation (out of 331 nominated projects). (quote from an e-mail from Štěpán Moravec, ERSTE Foundation in the Czech Republic)

CONSULTING

As part of our activities we provide expert consultation services in the field of multicultural education and migration to companies, schools and public institutions.

For company employees and managers we have prepared the Diversity Management educational programme which serves as a practical guide to understanding different cultures and working with them. For example, the programme prepares employees for long-term business stays in foreign countries, frequent cooperation with foreign business partners or foreign company management, and contact with foreign employees. The programme also helps its participants to develop intercultural competences, i.e. improve their ability to cooperate with people from different national cultures, understand the habits of their business partners, respect different attitudes and adapt themselves to culturally diverse working environments. The courses are focused on specific cultures (Russia, India, China) and are tailored to our clients' needs. Courses which can take one day or several days are meant for company employees and managers and are suitable for both groups and individuals; in case of long-term business stays even the employee's family members can participate.

We have also prepared a new type of courses: training courses for companies with large numbers of foreign employees. The training course provides an overview of applicable legislation and expected future developments in migration policy, both from the employers' and the employees' perspective. At the same time participants learn information and skills that are useful in communicating with foreign workers from different cultures; the programme can focus on the specificities of one of more cultures, e.g. Vietnamese, Mongolian, Ukrainian, Indian, Bulgarian, Romanian, etc.
